We will retain and use your personal data to the extent necessary to comply with our legal obligations, including those set forth under the funding regulations at under Section 5001(d) of the Cares Act P.L. 116-136, including retaining the documentation you provide us for this grant application for a period of up to five (5) years after final payment is made.
